Former Brumby's bakery boss **Michael Sherlock** has been made an Adjunct Professor at Griffith University's Griffith Business School.

The new position will see Sherlock share his wealth of franchising experience with Griffith Business School's Asia-Pacific Centre for Franchising Excellence.

Adjunct Professor Sherlock's appointment builds on his existing links with the centre as a member of its advisory board. The school says it is delighted to have a prominent, high-profile franchise leader such as Sherlock to provide strategic insight to both the centre and sector.

We wonder if he will insist on taking the Professor title as seriously as **Clive Palmer**.

"After many years of experience in franchising, I'm looking forward to giving back to the sector that has looked after me all these years to now pass on the benefit of my experience," the good professor said.

Despite stepping away from Brumby's he has his hands full and sits on several advisory boards as a strategist and mentor.

Under his leadership he grew the Brumby's brand from an ailing set of bakery shops into one of the largest bakery franchise systems in Australasia, and drove the share price from 56¢ to \$3.40 in just over three years.

In 2007, Sherlock resigned from the franchise after ASX-listed RFG purchased Brumby's for \$46 million. He has since parked most of his Brumby's cash with **Warren Ebert's** Sentinel Property Group which he sees as "a sure bet".


He's currently bankrupt but was in Federal Court yesterday, trying to overturn an inability to get permission from his bankruptcy trustee to leave the country.
